REGULATIONS AND CONDITIONS: Camping le Bois de Pins

- 1) A maximum of 6 persons may be registered on one pitch, children included.
- 2) At least one of the occupants must be over 18 years old. Minors must be accompanied by either their parents or legal tutors. Each member of the party must be in possession of an identity card to justify their name, age and address.
- 3) All visitors to the campsite are required to come into the reception office upon arrival to be registered as 'VISITORS'. Their cars are to be parked outside of the campsite. If your visitors would like to spend the night over with you, they will be registered as 'EXTRA PERSON' (additional fees) Extra persons are only accepted as long as the maximum number of people allowed is not exceeded on the pitch, or in the accommodation (additional fees).
- 4) The balances owing are to be paid in full on arrival in the following cases: arrivals without reservation, use of extra facilities, and any changes made regarding your reservation that will influence the final costs of your stay.
- 5) For the accommodations, the reception will hand out an inventory list, which must be filled out, signed and returned within the following 24 hours.
- 6) All DOGS must be registered at the reception, have a tattoo (card) and a valid/up to date vaccination certificate. At the reception pet 'waste bags' are at your disposal for free. On site your dog must be kept on the leash, and they are not allowed in the swimming pool).
- 7) Don't leave any items on the clothesline during the night. Use a chain for locking your bike or other objects left outside. We strongly advise you not to keep any objects of value or money on your pitch or without protection. The campsite does not accept any liability for any theft of valuables.
- 8) Access to the pool-area is exclusively reserved to our customers. Clients must wear traditional swimwear (tight): Bermuda pants and shorts are strictly forbidden in the swimming pools.
- 9) Barbecues with coal are not allowed.
- 10) The speed of all vehicles is limited to 10km/h, and circulation on the campsite is forbidden between 23h30 and 6h30.
- 11) The sanitary facilities must be left clean and tidy. They are no playground.
- 12) In respect of the other guests there is a 'peace and quiet' - policy from midnight on
- 13) The good reputation of our campsite has been based on friendliness, joy, quality, and hospitality: the infrastructures, organization and programs are all defined according to this approach. We reserve the right to refuse or compel guest(s) to leave who are not respecting our policies or are behaving in another unacceptable way.
- 14) On the day of departure, the keys must be handed in before 10h00, pitches must be free from 12h00 on. For any delayed departure, you may be charged for an additional day at the price for that night.
- 15) In the event of a dispute, the jurisdiction will be reserved for the Court of Perpignan. All claims concerning a malfunctioning of the company must be made in writing within the 30 days after departure.

Extra information for the rental of accommodations:

- 16) At the moment of departure your accommodation should be perfectly clean (before 10h00). If you do not wish to clean yourself, you can choose to pay for a 'Final Cleaning' (dishes excluded) at the reception.

17) Until a day before departure you can schedule a CONTROL OF YOUR ACCOMODATION for the morning of departure, to Ensure that there is no problem concerning the CLEANING or inventory of your accommodation.

18) The accommodation will be checked by us, with or without your presence. If the final cleaning has not been done according our standards, you will be charged of a FINAL CLEANING FEE (maximum of 60€).

19) In the unfortunate event that your damage costs more than the security deposit amount (200€ to 400€) the company can claim extra charges.

GENERALES CONDITIONS OF RESERVATION Camping Le Bois de Pins

- 1) The reservation of a pitch or accommodation indicates the full acceptance of all our Terms and Conditions.
- 2) The reservations can't be transferred or sub-let to other persons without the agreement of the management of the campsite. The management has the right to refuse persons of which the names are not mentioned in the completed and signed 'booking request'.
- 3) Pitches and accommodations are allocated without distinction, in the order of which the reservations are registered and according availabilities in the planning. The management reserves the right to make changes at any given time.
- 4) All 'Reservation Options' will only be valid during a restricted time 10 days. After this period they will be cancelled without warning.
- 5) The reservation only becomes effective after confirmation by our reservation services. This confirmation will be sent after the reception of your booking request (completely filled out and signed) with the down payment and administration fee. This receipt must be shown at the reception on arrival.
- 6) The balance of your stay must be paid 30 days prior to the intended date of arrival. In case of a reservation that is made in the 4 weeks prior to the arrival date, the whole amount must be paid when making the reservation.
- 7) In the event that the balance due is not fully paid on the agreed date, the campsite has the right to cancel the reservation and retain the amount already paid.
- 8) Reservation costs are never refunded to the client.
- 9) Pitches and accommodations should be occupied before 20h00. If the client cannot manage to arrive on time, the reception must be informed. Instructions will be transmitted for late arrivals
- 10) In the event of late arrival or early departure there will be no reduction in the rental fee for the initial period of your
- 11) In case of change of arrival/departure dates, only written messages (email, fax or letter) are accepted, otherwise the pitch or accommodation will become available again 48h after the requested date of arrival. The down payment will not be refunded.
- 12) In the event of cancellation before the 31th May, the down payment will be (partially) refunded: 100% for the pitches and 50% for the accommodations. After this date no refunds will be made. WE ADVISE YOU TO TAKE OUT A PERSONAL CANCELLATION INSURANCE IF NEEDED.
- 13) ABSENCE OF RIGHT TO WITHDRAW In accordance with article L.121-19 of the French consumer code, Camping Le Bois de Pins informs its customers that the sale of, accommodation services provided on a specific date or in line with a specific timeframe, is not subject to provisions regarding the 14 day withdrawal period.
